Foreword

IOparteciPA is founded on the belief that a thriving city is not made up solely of infrastructure, but of people who think, observe, imagine, and care for their communities.

In recent years, citizens have increasingly delegated:

- the management of their cities,
- the maintenance of public spaces,
- collective decision-making.

This delegation has created distance, disengagement, and mistrust. It has turned citizens into spectators and occasional commentators, and has often left local administrations alone — without a steady flow of civic support that is competent and constructive.

*In this vacuum, a narrow vision of citizenship has emerged:
not as an active resource, but as a problem to be managed.*

Artificial Intelligence as a Crossroads

The rise of Artificial Intelligence makes this historical transition even more delicate.

AI has the potential to:

- streamline processes,
- support decision-making,
- improve public services.

But it can also:

- encourage total delegation,
- diminish critical thinking,
- stifle collective intelligence,
- further alienate citizens from civic life.

For some models of power, a passive and disengaged citizen is easier to influence. For us, **that is a democratic, social and cultural loss.**

The IOparteciPA Approach

IOparteciPA was created to **reverse this trend**.

We believe:

Artificial Intelligence should not replace citizens, but rather create the conditions for them to participate more effectively, think more critically, and contribute actively to the care of their communities.

In our model:

- Humans remain at the helm;
- AI takes care of repetitive, low-value tasks;
- people retain what makes them unique: imagination, intuition, critical thinking, and civic responsibility.

IOparteciPA does not promote forced participation. It enables participation that is **voluntary, informed** and **constructive**.

Activating Civic Intelligence

Every citizen has a unique perspective.

Every everyday observation can become useful information.

Every contribution can improve the quality of collective life.

The issue is not a lack of civic intelligence — but a lack of **tools that activate and value it**.

IOparteciPA exists to:

- stimulate active observation,
